Please note you must provide your own Tent, Tables and weights for outdoor market times. These are mandatory, and without weights you will not be allowed to set up for insurance purposes. You may bring Chairs, tablecloths, displays, signs, bags, sanitations supplies, and all other necessary items for your booth.

Groups must arrive at the market 60 minutes prior to start of the market session. For the health & safety of the vendors/patrons this will be strictly enforced.

Please see the Market Manager upon your arrival for your space assignment. Due to the nature of weather and special events, your space may change on different event days. Parking will not be with your booth, however you may empty your items from your vehicle and then proceed to park in the lots.
